Attached please find a draft resolution for the Academy Board to use in approving the Plan and Contract amendment.

#### **District/ PSA Response:**

West Michigan Academy of Environmental Science will provide instruction through a blended learning option for students. The students will have access to learning through a virtual or offline method. The virtual method will utilize the platform of Google Classroom. Paper resources will be picked up on the first day of the plan by family members who chose that learning path. Resources will

be mailed home upon request.

All parents have been contacted to complete a survey to inform West Michigan Academy of Environmental Science team members of the technology access in the student's home. Utilizing that information will allow the WMAES team to determine the learning path of the student. Whether the student is on the virtual or offline path, the same standards will be presented.

Utilization of platforms such as Zoom and Google Hangouts will occur for those that need support with instructional activities. To ensure full access, either of these platforms can be accessed through a phone number as well as computer. For those that have access to the internet but do not have a device, a Chromebook will be loaned to them for the duration of the distance learning plan. For the offline path, pencils, crayons, and paper will be given to students to complete their assignments given by the teacher.

To support our English learner families, the WMAES team will utilize the communication tool of class dojo which is able to translate information. Three team members on the WMAES team are fluent in Spanish. They will be tasked with assisting families that are in need of translation or language support. Teachers also have preliminary training on SIOP strategies which will encourage language development. Spanish is the only other language spoken by families at WMAES.

• Please describe the methods the district will use to keep pupils at the center of educational activities, including outreach to continue building relationships and maintain connections, and to help pupils feel safe and valued.

#### **District/ PSA Response:**

West Michigan Academy of Environmental Science will keep student relationships at the core of our distance learning plan. The entire WMAES team has already participated in a trauma informed professional development to create a supporting mindset of all students.

To ensure consistent communication and connection, West Michigan Academy of Environmental Science has the following requirements of their teachers. Office hours will be held each week to connect with both online and offline students. All students must be contacted at least once in the week by a WMAES staff member. If a student has been contacted 3 times by an instructor with no response, then the support team will reach out utilizing all contact methods until a response is received. This support team will include instructional aides, office staff, student advocate, and administration.

The social worker at West Michigan Academy of Environmental Science will continue to reach out to

students who were on her caseload on a weekly basis. Peer connections will be sustained by class zoom calls and other team building activities provided by the teacher.

For students who have special education programs and services, we will be initiating a contingency plan, with parent input, to address the needs of each individual student.

Students with IEPs will be provided with learning opportunities in the same manner as general education students. These learning opportunities will include accessibility options as well as materials that have been accommodated and modified. Teachers will be supporting students through virtual or phone contact.

• Please describe the district's plans to deliver content in multiple ways so that all pupils can access learning.

#### **District/ PSA Response:**

West Michigan Academy of Environmental Science will utilize a blended distance learning approach. An offer of online and offline learning will be available. The online version will utilize Google Classroom for the platform. On this platform, assignments will be given in the required subjects for the student to receive credit. The teacher will provide instruction centered around the priority standards identified as needed to continue the learning in that grade level content. The teacher will create videos, host live zoom calls that will be recorded, share links and articles and/or type up notes to provide instruction on material.

Instructional materials will be decided on by grade levels to ensure consistency. Elementary teachers will utilize numerous resources including Amplify, Go Math, Freckle, Imagine Math, and others that fit the needs of the learners. Secondary teachers will utilize programs such as Khan Academy and other online resources to reach standard mastery. This will be up to the teacher's discretion but monitored by administration. Teachers will gain prior approval before recording virtual calls from parents. The assignments will be delivered and handed in through the platform or email. Each student has access to a log in.

The offline learning approach will consist of paper resources for the student to utilize for independent practice. The paper resources will be focused on the priority standards deemed necessary for the end of the year instruction. The instruction on the material will occur through Zoom or Google Voice calls. The instructional aides and specialists within the building will be available for assistance with paper resources as well. Paper resources will be picked up on the first day of the plan by family members who chose that learning path. Resources will be mailed home upon request. The assignments

will be turned in at the end of the time period. An outdoor drop-off location will be established for families to return paper resources. Protocol to maximize social distancing at the outdoor drop-off site will be communicated to parents/guardians. Following the time period allotted for returning paper resources, the returned items will be isolated for a period of time sufficient to ensure they are no longer infectious. After the isolation period, the returned items will be provided to teachers so they may review student work and provide credit to those who participated in the paper resource learning path.

All students will have access to office hours offered throughout the week by teachers, specialists, and instructional aides through the zoom application.

For students who have special education programs and services, we will be initiating a contingency plan, with parent input, to address the needs of each individual student. Students with IEPs will be provided with learning opportunities in the same manner as general education students. These learning opportunities will include accessibility options as well as materials that have been accommodated and modified. Teachers will be supporting students through virtual or phone contact.

#### • Please describe the district's plans to manage and monitor learning by pupils.

#### **District/ PSA Response:**

Teachers at West Michigan Academy of Environmental Science should be connecting with their pupils on a weekly basis. This will allow the teacher to provide feedback on assignments given in both virtual and offline paths. If a student has not been connected with after 3 attempts, the support team will use all contact information available to connect with that student. If a student does not show an understanding of the material, it is the responsibility of the instructor to provide more instruction around the topic. With the weekly phone connection, the teacher will check to see how the student completed the offline work. The teacher will provide feedback to the student during this weekly connection.

At the end of the year, teachers will grant credit to students who participate and are engaged toward the priority standards. Credit will be determined on a credit/no credit basis. Participation during the closure will determine whether credit will be determined.

## • Please describe the manner in which district administrators, board members, teachers, and any representatives of teachers collaborated in development of the Plan.

#### **District/ PSA Response:**

The West Michigan Academy of Environmental Science administration team led the collaboration of this plan. Once a framework was created, it was presented to teachers to allow for feedback and questions. Once that feedback was taken into consideration, the plan was presented to our curriculum team at Choice Schools Associates. When the feedback of this team was taken into consideration, the plan was presented to our board for input.

• Please describe the methods the district will use to notify pupils and parents or guardians of the Plan.

#### **District/ PSA Response:**

West Michigan Academy of Environmental Science will provide the information on the plan to students and parents immediately upon approval. A formal letter will be written to the WMAES community outlining student and parent expectations, as well as access to the entire plan. This letter will be sent through School Messenger to parent contact information. This letter will also be posted to

our school dojo and Facebook page to ensure parents have been contacted. The plan will be posted to our website and a call will be sent to parents to inform them of this location. The formal letter and a copy of the plan will be distributed during the offline resource pick up.

#### **District/ PSA Response:**

For our students in dual enrollment courses we will be working with the provider to determine next steps. We will ensure that the students have the appropriate materials and support to complete those courses. The students will be given the option to convert their grade to credit or no-credit. For students in CTE programs we will work with the ISD CTE Director as well as state level CTE directives to ensure our students have the ability to complete these courses. When needed the district will ensure the student has the necessary resources.

• Please describe how the district will continue to provide or arrange for continuation of food distribution to eligible pupils.

#### **District/ PSA Response:**

West Michigan Academy of Environmental Science has distributed meals since the closure began. Meals are distributed from 10am-12pm Monday and Wednesday every week. Two breakfasts and two lunches for each child are provided at Monday food distributions. Three breakfasts and three lunches for each child are provided at Wednesday food distributions. This information has been posted on our website, Class Dojo, and Facebook page. This information was also sent to families in multiple letters and in multiple newsletters. Communication about meals was also delivered in Spanish.

#### **District/ PSA Response:**

All employees are expected to participate in the approved Continuity of Learning Plan and may be asked by the school leader to work in a role different than what was in their original offer of at-will employment for the 2019-2020 school year. School leaders will take each employee's strengths and growth plans into consideration when making these assignments and will communicate them clearly in writing to each hourly employee assigned to a different role than what was stated in their offer of at-will employment.

Employees assigned to the Academy in the board-approved budget will be paid as outlined in their signed offer of at-will employment for the 2019-2020 school year. The offers of at-will employment for the 2019-2020 school year have not been amended due to circumstances surrounding COVID-19. If the school's spring break falls during the closure, hourly staff will be paid and will not have to use Paid Time Off (PTO). Teachers are required to provide their students with learning opportunities as outlined in the approved Continuity of Learning Plan and in accordance with the expectations of the school leader.

At a minimum, hourly staff will be paid based on the average number of hours worked during a normal week. The average hours of a normal week will not include overtime. If the school leader asks an hourly employee in writing and in advance to work beyond the average number of hours of a normal week, the hourly employee will be paid for those leader approved hours. Hourly employees will be asked by the school leader to help with tasks to assist with the continuity of learning plans.

### • Provide a description of how the district will evaluate the participation of pupils in the Plan.

#### **District/ PSA Response:**

Teachers will utilize participation in Google Classroom, if they are taking the online path. If a student is in need of a Chromebook to participate in this path, one will be provided for the family. If a student does not have access to the internet, teachers will keep track of which students are completing the weekly instructional packets. If a student has access to technology, teachers will use the instructional platform to monitor student wellbeing, engagement, and completion of assignments. Teachers will also keep a log of communication with students and families. When completion and/or communication from students are inconsistent, staff will intervene to ensure a connection is made. A support team of staff members has been established for this purpose. If communication cannot be established following intervention by the support team, the WMAES administration team will collaborate with the teacher and develop a plan to connect with the student and family.

WMAES students will have access to mental health supports through a variety of avenues. WMAES staff members recently completed online professional development regarding trauma-informed classrooms. Teachers and members of the support team will be approaching remote learning with a focus on key trauma-informed concepts.

Teachers will work together with members of the support team to ensure consistent connections are made with all students to provide for regular check-ins regarding their wellbeing. The support team will intervene with additional communication when difficulty making these connections arises. Additionally, staff members may refer students to the support team for follow-up contact as needed. All West Michigan Academy of Environmental Science staff members have been reminded that their obligation as mandated reporters extends into this period of remote learning.

The school social worker on the WMAES team has been active since the first day of the closure and is making weekly phone calls to connect with our most emotionally vulnerable students. The student advocate on the team has been supporting the school social worker in contacting and providing support for these students.

WMAES' school social worker sent written communication to all families regarding student mental health concerns which may come about during the current health crisis and the support that is available. In addition to providing her contact information for support requests, she provided a list of community resources available for student mental health support. The student advocate at WMAES has also prepared communication for families regarding available resources and encouraged contacting her for support. Additional mental health resources will be shared with our community through our bi-weekly newsletter, social media pages, and on our website.

Please describe how the district will support the efforts of the intermediate district in which the district is located to mobilize disaster relief child care centers as described in Executive Order hoho-gl or any executive order that follows it.

#### **District/ PSA Response:**

WMAES does not currently provide a disaster relief child care center. The Academy will continue to cooperate with requests from the local intermediate district with regard to any necessary disaster relief child care centers and will share relevant information with the school community.
